- We have started our inventory on the lots for the 2020 parking season. The purpose for this early start is to have them ready for the 2020 event season no later than April 1, 2020.
- We have a meeting coming up with Live Nation and the Mayor to go over the parking inventory we have in and around the waterfront and to see how we can expand on our parking.
- New Year's Eve firework shows will be at 6pm and midnight. The 6pm show will be more family friendly so we will have music and activities before the show.

### Willie Hunter

- We have increased revenue on Block N by providing parking for the constructions workers who are working on the Cooper Street Project.
- Live Nation has approved some repair work on Lot 1, 30 and a few others out of the Cap X Fund. We should be gathering all the information regarding repairs soon.
- The Hinson Garage restoration work approved in September's board meeting started on December 9, 2019. The structural repairs on the beam on the third level has been started. We have parked some of Cooper's employees on Block 1400 while the work is being completed.
